Key:

DGR - Dangerous Goods Regulations Acceptance (Initial) – 5 Days

- This course is for new or first timers who have not sat any Dangerous Goods courses
- Or for an expired license holder whose currencies have been expired.

DRR - Dangerous Goods Regulations Acceptance Refresher (Recurrent) – 3 Days

- For those license holders whose currencies are expiring within the next 3 months, as per DGR 1.5.0.3.
- A License holder **must** (mandatory) renew the license within 90 days prior to expiry date.

IMDG – Dangerous Goods by Sea Transport – 3 Days (NEW)

- **Prerequisite for IMDG training – Participant MUST hold a Category 6 IATA DGR License!**

IMPORTANT TO NOTE!

If your license has already expired, the Category 6 license holder must re-sit the Initial DGR training in compliance with the IATA DGR Regulations, Training Requirement (1.5.0.3) and Civil Aviation Safety Authority (CASA) PNG CAR Part 92.205 (a) and (b). Failure to comply with the Regulators means that your license may be removed.
